

St Louis Triathlon Club Equipment Rental Agreement

RENTAL ELIGIBILITY

In order to rent equipment from the St. Louis Triathlon Club, the following are required.

- Must be a member of the St. Louis Triathlon Club
- Must be in good standing and current with both dues and membership
- Must live local to the St. Louis metropolitan area.

RENTAL EQUIPMENT SUBJECT TO THIS CONTRACT

The St. Louis Triathlon Club shall rent the equipment listed under Appendix A below.

MAINTENANCE AND REPAIR

The Customer shall maintain the equipment in good repair and operating condition, allowing for reasonable wear and tear.

The Customer shall pay all costs required to maintain the equipment in good operating condition. Such costs shall include labor, material, parts, and similar items.

RISK OF LOSS OR DAMAGE

The club member assumes all risks of loss or damage to the equipment from any cause, and agrees to return it to the St. Louis Triathlon Club in the condition received, with the exception of normal wear and tear. The St. Louis Triathlon Club or their appointed agent will determine normal wear and tear. All determinations made by the St. Louis Triathlon Club are final. The Customer shall pay all replacement costs in the event of loss.

ACCEPTANCE OF EQUIPMENT

The club member shall inspect each item of equipment delivered pursuant to this Rental. The club member shall immediately notify the St. Louis Triathlon Club of any discrepancies between such item of equipment and the description of the equipment in the Equipment Schedule. If the Customer fails to provide such notice at time of acceptance, the club member will be conclusively presumed to have accepted the equipment as specified in the Equipment Schedule. Any subsequent claim that the equipment was not provided in fully functional order will not be considered.

RETURN OF EQUIPMENT

At the end of the Rental period, the club member shall be obligated to return the equipment to the St. Louis Triathlon Club. It is the club member's responsibility to contact the St. Louis Triathlon Club and schedule a return meeting date/time.

ASSIGNMENT

The club member shall not assign or sublet any interest in this Rental or the equipment or permit the equipment to be used by anyone other than the club member, without prior written consent from the St. Louis Triathlon Club.

ENTIRE AGREEMENT AND MODIFICATION

This contract constitutes the entire agreement between the parties. No modification or amendment of this contract shall be effective unless in writing and signed by both parties. This contract replaces any and all prior agreements between the parties.

WARRANTY

The St. Louis Triathlon Club makes no warranties; express or implied, as to the equipment rented. The club member assumes the responsibility for the condition of the equipment.
